**Pascal Kerneis** is the Managing Director of European Services Forum (ESF), a business organisation representing the European services industry in the international trade and investment negotiations. He was legal expert in the European Commission in Brussels, and then worked for the European Banking Federation as international affairs adviser. He has been appointed member of various Commission DG Trade's advisory groups, and participated to all WTO Ministerial Conferences as Commission's advisor.

**Hazel Moir** is a VF at the Centre for European Studies (ANUCES), Australian National University. Hazel does research on patent policy and its impact on the cost of medicines; aspects of global migration, especially family reunion migration; aspects of trade in services; and the economic impact of geographical indications. Hazel's research interests include: Patent policy, Copyright policy, International "trade" agreements, Role of "IP" in corporate taxation

**Anne McNaughton** was appointed as Director of the ANU Centre for European Studies in 2020. She is a comparative lawyer who researches at the intersection of international and comparative law. She has also been a member of numerous research projects, including projects funded through the European Union's Jean Monnet activities programme and is currently a research lead in a Jean Monnet Centre of Excellence for EU - Australia Economic Cooperation based at the ANU Centre for European Studies.

**Maria Garcia** is an Associate Professor and Head of the Department of Politics, Languages and International Studies at the University of Bath in the UK. Her research focuses on the politics of trade agreement negotiations, geoeconomics competition in free trade agreements as well as societal aspects of trade agreements. She is one of the special advisors to the UK's Parliament's International Trade Committee. She is co-editor of the Handbook of EU and Trade Policy (2018, Edward Elgar) and co-editor of Latin America-EU Relations in the 21st Century (2022, MUP).

**David Henig** is Director of ECIPE UK, and Director of the UK Trade Policy Project. A leading expert on the development of UK Trade Policy post Brexit, in 2017 he co-founded the UK Trade Forum, which brings together UK trade policy experts to debate and analyse these issues. After the UK referendum vote he helped establish the new Department for International Trade, engaging in many of the UK's first working groups with non-EU countries, and setting out options for engagement with the US. He is special advisor to the House of Lords Committee on International Agreements. David started his career before Government in consulting and business development, having graduated from Oxford University.

**Erik van der Marel** is a Chief Economist at the European Center for International Political Economy (ECIPE), Associate Professor at the Université Libre de Bruxelles, and Consultant Economist at the World Bank. His areas of expertise are in digital trade, services trade, cross-border data flows, and their associated digital services trade policy.
